Bhopal Sahkari Dugdh Sangh Maryadit, Bhopal invites online tenders from bonafide manufacturers / associates of such manufactures and their accredited representatives for supply and installation of total 13 Nos. **CLOSE CIRCUIT CAMERA TELEVISION (CCTV)** in the existing CCTV system for Cattle Feed Plant, Pachama in adherence to the detailed specifications given in the Schedule II of this Tender.

Chief Executive Officer of Bhopal Sahkari Dugdh Sangh Maryadit, Bhopal reserves the right to accept or reject any or all tenders, which in their opinion justify such actions, without further explanation to the tenderers.

1.0 DECLARATION :

The submission of a tender by a tenderer implies that he/she has read the notice and conditions of the tender and the terms and conditions of contract and has made himself/herself aware of scope and specifications of the supplies to be made and the destination where the supplies have to be made and satisfied himself/herself regarding the quality and specifications of the articles.

2.0 TENDER SUBMISSION:

- 2.1 Tenders received by e-mail / by post will not be considered.
- 2.2 The tenderer(s) should clearly state in their offer the address, telephone, fax, e-mail, PAN and GST Number. Any change in the address should immediately be communicated to the Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Mydt, Bhopal and correspondence thereafter will be made at the changed address.
- 2.3 The acceptance of the tender and award of the purchase order will be the sole right of the Chief Executive Officer, Bhopal Sah. Dugdha Sangh Mydt. Bhopal who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded of the cause of rejection of the tender by any tenderer.
- 2.4 The Chief Executive Officer, BSDSM reserves the right to place order for whole requirement with any tenderer or split the orders among one or more tenderers or not to purchase at all any item even after rate approval.
- 2.5 The Tenderers should submit the tender rates in the enclosed Schedule IV only. The conditional tenders will be rejected.
- 2.6 No person or firm is permitted to submit more than one tender under different names.
- 2.7 The tenderer shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract without prior written permission of Chief Executive Officer, BSDSM.
- 2.8 Demonstration of equipment, machines or articles available with the firm shall be arranged by the tenderer at his own cost, whenever requested by Bhopal Sah. Dugdha Sangh Mydt.
- 2.9 Tenderer shall fill all the details of the unit and technical details of machine exhibited for sale in the enclosed form- A,B in schedule-III. (To be uploaded –mandatory.)
- 2.10 Tenderer must be manufacturer/distributor/dealer/supplier of machine.

Bid Validity

Bid shall be valid for a period of 90 days from the date of opening.

Documents composing the Bid

Technical bid:

1. Bid Security(EMD) – Scan copy to be uploaded (Form –A)
2. Technical bid form filled(scan copy to be uploaded) Form-B
3. Tender document each page sealed and signed as token of acceptance to each and every terms and conditions

From sl.no.1 to 3 document must be submitted in hard copy before bid submission end date and time.

3.0 Earnest Money Deposit

3.1 All the tenderers shall be required to pay Earnest Money as specified by the Sangh in the form of crossed **Demand Draft drawn** in favour of **Bhopal Sahakari Dugdh Sangh Mydt, Bhopal**. Submission of Earnest Money by any other mode than specified above shall not be acceptable and in such case the related tender shall not be eligible for consideration. Details of Earnest Money deposit is as under

“EMD FOR CCTV - RS 10,000/- ”

3.2 Any Tender which is not accompanied by Earnest Money Deposit shall be rejected. Earnest Money Deposit of unsuccessful tenderers will be returned within 30 (Thirty) clear Days from the date of opening of the tender. The Earnest money deposit of the successful tender will be released on completion of supply/work as the case may be within the stipulated period.

3.3 No Interest will be paid for the Earnest Money for the period during which it (The Earnest Money) lies in deposit with the Bhopal Sahakari Dugdh Sangh Mydt, Bhopal.

3.4 Demand Draft towards Earnest Money should be submitted under separate sealed cover along with Mandatory and Technical Documents.

4.0 Prices

4.1 Prices offered by the tenderers should be firm and free from all escalations. The prices offered should be valid at least for a period of 3 months from the date of approval of rates, BSDSM, Bhopal would communicate rate approval within 30 days from the date of opening of tender.

4.2 The tenderer should quote only. F.O.R Dairy Plant rates.

4.3 The tenderers should quote rates as per rules only.

4.4 Octroi, if applicable at the destination, shall be paid extra on all the first dispatches made from the suppliers work / warehouse to the point of destination.

4.5 The supplier must complete the entire works as specified in the Work Order of BSDSM, Bhopal within 30 days from the date of work order.

5.0 Payment

- (i) Our normal terms of payment is 90% payment after receipts, inspection, installation and successful trial run within a period of about 30 days after receipts.
- (ii) Rest 10% after submission of performance bank guarantee with validity not less than one year from date of commissioning.

6.0 General Terms and Conditions

6.1 The acceptance of the Tender and awards of the work order will be the sole right of Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Maryadit, who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reason and no explanation can be demanded of the cause of rejection of the tender by any tenderer.

6.2 If the tenderer fails to complete the job within the stipulated time, one month maximum mentioned in the work order then they may be black-listed and EMD/SD also may be forfeited.

6.3 No responsibility shall be attached for premature opening of tender, not properly addressed and identified. The tenderer received against the advertisement upto the specified time limit shall be considered. But the lowest rate shall not be the only criteria for awarding the tender.

6.4 Negligence on the part of tender in filling the tender offers, shall have no right to withdraw the tender after it has been opened.

6.5 Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Maryadit, Bhopal reserves the right to place order for sole requirement with any tenderer or split the orders among one or more tenderers

6.6 The tenders received against the advertisement upto the specified time limit shall be considered. BSDSM, Bhopal shall not be bound to accept lowest rate tender.

6.7 Each tender should be accompanied with Income Tax Clearance Certificate(ITR for last two years), Sales Tax number and PAN number, without that, the tender may not be entertained.

6.8 The submission of the tender by a tenderer implies that he has read and notice and conditions of the tender and the terms and conditions of contract and has made himself aware of scope and specification of the works to be done and the

destination where the work has to be done and satisfied himself regarding the quality and specifications of the articles.

- 6.9 The tenderers should submit technical bid of the tender in the enclosed form only.
- 6.10 The conditional tenders are liable to be rejected.
- 6.11 No person or firm is permitted to submit more than one tender under different names.
- 6.12 Each page of technical bid of tender and its enclosures should be signed at the bottom by the tenderer.

7.0 Inspection

- 7.1 All the work carried out are subject to inspection at BSDSM, Bhopal works before acceptance. If work is not found satisfactory, no payment will be made till its repair/rectification as per specifications.

8.0 Termination of Contact

- 8.1 Any act of omission or commission of a unit brings BSDSM, Bhopal to dispute, BSDSM, Bhopal shall be competent to debar / blacklist the unit from further business with BSDSM, Bhopal.

9.0 Drawing & Specifications

- 9.1 Rate should be quoted for the specification given in the Schedule II
- 9.2 If the tendering unit has any doubt as to the meaning of the conditions or the specification and drawing or plan, tenderer shall before submitting the tender set-forth the particulars thereof , and submit them to BSDSM, Bhopal in writing in order that such doubt may be removed.

10.0 Consequences of breach of agreement

- 10.1 If the authorized person of the unit or a partner in the contract/tendering firm commit breach of any of the conditions of agreement it shall be lawful for the Chief Executive Officer, Bhopal Sahakari Dugdha Sangh Maryadit, Bhopal to cancel the contract.

11.0 Dispute, arbitration and final authority

- 11.1 It should be clearly understood that in the event of tender failing to accept and execute the work order, decision of the Chief Executive Officer, BSDSM, Bhopal in this respect will be final and binding in the tenderer.
- 11.2 At the time of submitting the tender, tenderer shall supply detailed information about their activities in the enclosed form.

- 11.3 For matters of dispute, relating to the interpretation of the above clause, the decision of Chief Executive Officer, Bhopal Sahakari Dugdha Sangh Maryadit shall be final and binding on all concerned.
- 11.4 For all disputes the venue shall be at Bhopal only.
- 11.5 For matter related to arbitration, Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Maryadit shall be sole arbitrator for finalization of issue arised and his decision shall be binding on both the parties i.e Purchaser and Supplier.
